

TRANSIENT STUDENT APPLICATION

Currently matriculated students in a degree program at another college may apply to take courses at Berea College as a transient student. With the exception of students whose permanent address is in Madison, Jackson, Rockcastle, or Garrard County Kentucky, these students are subject to the same financial restrictions for admission that apply to degree-seeking students. Transient students are restricted to two-and-one-fourth (2-1/4) credits per term of enrollment (one credit in Short Term), not to exceed three consecutive terms, and are accommodated on a space-available basis. Ordinarily, transient students are not eligible for off-campus courses, independent studies, internships, directed studies, and any other credit-bearing exercise pursued outside of the traditional classroom setting. **Summer and Short Term** transient students are not eligible to live on campus or to work in the College's Labor Program. **Fall and Spring Term** transient students may be required to live in a residence hall and work in the College's Labor Program.

To apply for transient student status, please submit this application along with the following:

- An official transcript listing work completed as well as work in progress, sent directly to us from the home institution
- A statement of good standing sent directly to us from the home institution (see reverse)
- FAFSA data (the Office of Student Financial Aid Services must verify financial need to determine admission eligibility). To submit the Free Application for Federal Student Aid, you should go to www.fafsa.ed.gov and request that your results be sent to Berea College, Code #001955. Make sure you submit the FAFSA data for the academic year that you will be attending Berea.

The application and supporting documents should be submitted to the Student Service Center – First Floor Lincoln Hall or CPO Box 2168, Berea, KY 40404. No action will be taken on the application until the transcript, statement of good standing, and FAFSA data have been received.
